In the run-up to Christmas, the RSPCA is always concerned about the prospect of people adopting or buying pets as Christmas presents. Far too often, these animals rapidly become unwanted and the RSPCA and other animal rescue charities have to deal with the increased numbers of pets that, through no fault of their own, are without a home; either dumped or signed over for rehoming.

This is the tale of one poor cat that had once been someone's pet. but for him his luck changed just before Christmas last year and he possibly had his best Christmas in a long time!

About this time last year, a concerned member of the public had handed a tatty black male moggy in to their local veterinary practice. He had been wandering in the area for some months but had obviously been out on his own for a lot longer.



He was in poor condition, thin, with fleas and sore eyes and looked a sorry sight.

The vet practice contacted this Branch and after

blood tests and some vital medical treatment he was given to one of our experienced fosterers, Angela, to start the process of rehabilitation. He needed lots of TLC, good food and encouragement. Angela named him 'Jack'. At the outset he was exhausted and once sure of his surroundings he relaxed, ate and slept, recovering his strength slowly. Every week brought something new and although initially nervous of strangers, improvements in his well being brought out the best in his personality. There were one or two minor hiccups with his health, which given his age (8-10 years old) and the fact he had been in such a bad way, wasn't surprising. Eventually after several months in our care, patience was rewarded and Jack found his new forever home. It was a match made in heaven.

Angela found it hard to part with Jack so she was delighted when she received this letter and photo earlier this year.

*Dear Angela*

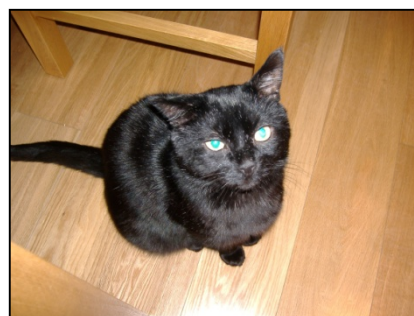

# Donate Don't Dump!



Every year this branch relies hugely on the support of the local community to turn peoples' unwanted clothes and possessions into cash by donating them to one of our three charity shops. Each of our shops receives a vast assortment of donations and our managers and volunteers work tirelessly to maximise the income by selling what they can and recycling what they can't. Most of what is recycled also earns the branch money. So far this year we have been paid around £8,000 for all the items we have passed to our recycling provider. In addition, selected items donated that are of higher value or are collectors' items are passed to our Ebay volunteers whose job it is to research the values of these items and list them for sale on Ebay. Those that don't sell are returned to the shops for them to hopefully sell. We constantly strive to make every penny we can, because every penny does count!

The income generated through our three shops provides the main financial resources for this branch which, in turn, enables us to make a significant level of expenditure on local animal welfare. In the first six months of this year this Branch has spent over £35,000 on veterinary care and finding new homes for local animals.

Whatever you have that you no longer want, please remember us and bring it to one of our shops and help us do even more in the future for the many needy animals in our area. Opening times are 9.30am-4.30pm Mon to Sat.

# Gift Aid your donations

*...Coming soon...*



Money doesn't grow on trees, but extra is there for the picking by us, if you are a UK tax payer.

Did you know that as a UK tax payer you can elect for us to claim back from the Government the tax you have paid, currently at the rate of 28p in every £1, for any items donated to our shops that we are able to sell?

**So what's involved?** Once our shops have the necessary till and paperwork systems in place, when you donate to one of them you will be asked, as a tax payer, if you are willing to complete a Gift Aid claim form. It takes 2 minutes and simply requires you to give your name, address and signature as consent for us to act as your "agent" in selling your possessions. You will then



be given a donor's card with a unique bar code number which will identify you to us for any future donations you make.

All your donations will be sorted separately and each item that we put out for sale will have a unique bar code sticker attached. When a customer goes to purchase any of these items, the bar code will be scanned at the till and that will automatically allocate the amount of the sale to your personal record, held on our system's database. Remember, this will be 28 pence for every pound sold (25 pence from April 2011), so the amount of gift aid claimable could mount up quite quickly.



Thereafter, each time the amount of gift aid claimable reaches a certain predetermined amount, we will write to you to advise you of the amount, which we are required to do by law.



Once a year all the shops' gift aid claims will be processed through HMRC and we will receive our entitled payment.

**If only 30% of all our donors were tax payers and agreed to allow us to claim gift aid, then this Branch could boost its annual income by more than £8,000. This has to be good news for local animals!**
